# TBH STREET FAIR AGREEMENT

## PLEASE READ AND KEEP THIS FOR YOUR RECORDS

The TBH Street Fair is run by volunteers, the TBH Street Fair Committee. All vendors are expected to help us make the event a success. The first bit of work we ask of our vendors (and the most important) is to read this application carefully. You turn in only the pages you fill out. KEEP THIS LETTER AS A REFERENCE. If you have questions or you want to submit your application electronically, email us at [streetfair@bethhatfiloh.org](mailto:streetfair@bethhatfiloh.org) and you can also mail or drop off the application at TBH (201 8<sup>th</sup> Ave. SE).

The fee for food vendors is \$54 per 10' x 10' space and \$108 for a 10' x 20' space. Non-food vendors pay \$36 per 10' x 10' space and \$54 for a 10' x 20' space. Non-profit groups are asked to provide a free activity for ages 4-14 in lieu of a cash payment for a 10' x 10' space.

Include a check with your application made out to "TBH". Vendors who are not accepted will receive their check returned in the mail. There are no refunds for accepted vendors who cancel after May 10 or who don't show up on June 2.

We will close 8<sup>th</sup> Avenue between Washington and Franklin to traffic at 5 pm, Saturday, June 1. Vendors are invited to show up at 6 pm, Saturday when we are assigning spaces. If you are there, you will have the opportunity to choose your space. Vendors not attending the Saturday evening meeting will have a space assigned to them. PLEASE don't bring anything to leave in your space overnight.

Coming the night before will help you feel ready. We can answer any of your questions and when you show up Sunday morning you can focus on setting up and getting your booth together.

We allow groups of people to share a single space. If you are sharing a space have each member read and sign this application. It's not required that each member comes the night before, but we recommend it so you avoid having members that are confused the next day.

It's not as much fun to have the Street Fair if there's even a small amount of rain, so we ask everyone to cross their fingers. We don't have a rain date and we have very limited indoor options. We recommend having a 10x10 pop tent, rain or shine.

Vendors are asked NOT to come before 9 a.m. on Sunday when we are doing set-up and need the street empty. The vendor unload time is from 9-10 a.m. Trying to unload after 10 a.m. will hopefully be impossible given the large crowds we're expecting. Do not drive onto the street fair. Vendors located near the Washington/8<sup>th</sup> intersection may park temporarily in the crosswalk. Vendors located near the Franklin/8<sup>th</sup> intersection may unload from the crosswalk. We'll have volunteers at either end to help direct traffic, but please don't block the intersection. On weekends parking is free on the streets and in the city and state lots.

Vendors provide their own tables, racks, shelves, etc. If you need to extend into your neighboring space(s) please negotiate with your neighbors when you meet them the night before the street fair. On the day of the street fair it's recommended to bring: water, sun block, an umbrella or canopy tent, comfortable shoes, a chair, \$20 in small change (especially \$1 and quarters) and food to eat. Please leave your dog(s) at home and don't smoke in the street fair.

All food vendors need to be properly permitted to participate. Please enclose a copy of your general operating permit with your application and remember to bring your event documentation with you on June 2.

We don't allow the sale of weapons, drugs, drug paraphernalia, tobacco or alcohol. We don't allow professional vendors selling factory packaged merchandise.

Vendor applications are subject to review by the TBH Street Fair Committee. Applicants will be contacted by email on or before May 7, 2013. Vendors may be asked to remove items from their booth at the discretion of the Event Organizer. Vendors requiring electricity, please let us know how much. Power is very limited, we may not be able to accommodate, if we can, there will be an additional fee based on draw and usage.
